## SECTION C. Mode Of Payment

1. For those who have completed and submitted the EPSO (**applicable to Singapore Citizens only**), payment for the enrichment programmes listed in **Section A – Level –Wide Enrichment Programmes**, \$54 will be deducted from your son's EPF account. You may get a copy of the EPSO form from the school office if necessary. If you have not signed up for the EPSO or if you have insufficient balance in your child's EPF account, the cost will be deducted from your GIRO Account if you have signed up for the Giro Option on the 6<sup>th</sup> of the following month upon bill generation. Please find attached the GIRO form for your completion. Please submit by **Mon, 25 June 2018**. You may also pay the costs by cash/cheque or at AXS machine upon receipt of the school bill.
2. For items listed in **Section B – Non-Enrichment Programmes**, \$ 5, payable by **Giro, Cash/Cheque or via AXS Machines**.
3. You may check your son's EPF balance via the hotline 62600-777 (Singapore citizens receive \$200 in their Edusave Account yearly.)
4. For Singapore Permanent Resident or International Students, \$ 59 for the items listed in Sect A & B, is payable by **Giro, Cash/Cheque or via AXS Machines**.
5. All payments for items in Sect A & B must be received by **Mon, 25 June 2018**. Cash and cheque payments can be handed to the Form Teacher. All cheques are to be made payable to "**St Stephen's School**".
6. Please note that your child not be permitted to participate in enrichment programme/activities if payment has not been made prior to the commencement of the programme/activity.
7. There will be no refund of the programme fees for absentees without valid reasons. For absentees un 20with valid reason, request for refund will be considered on a case by case basis provided the vendor charged on actual day attendance.
